

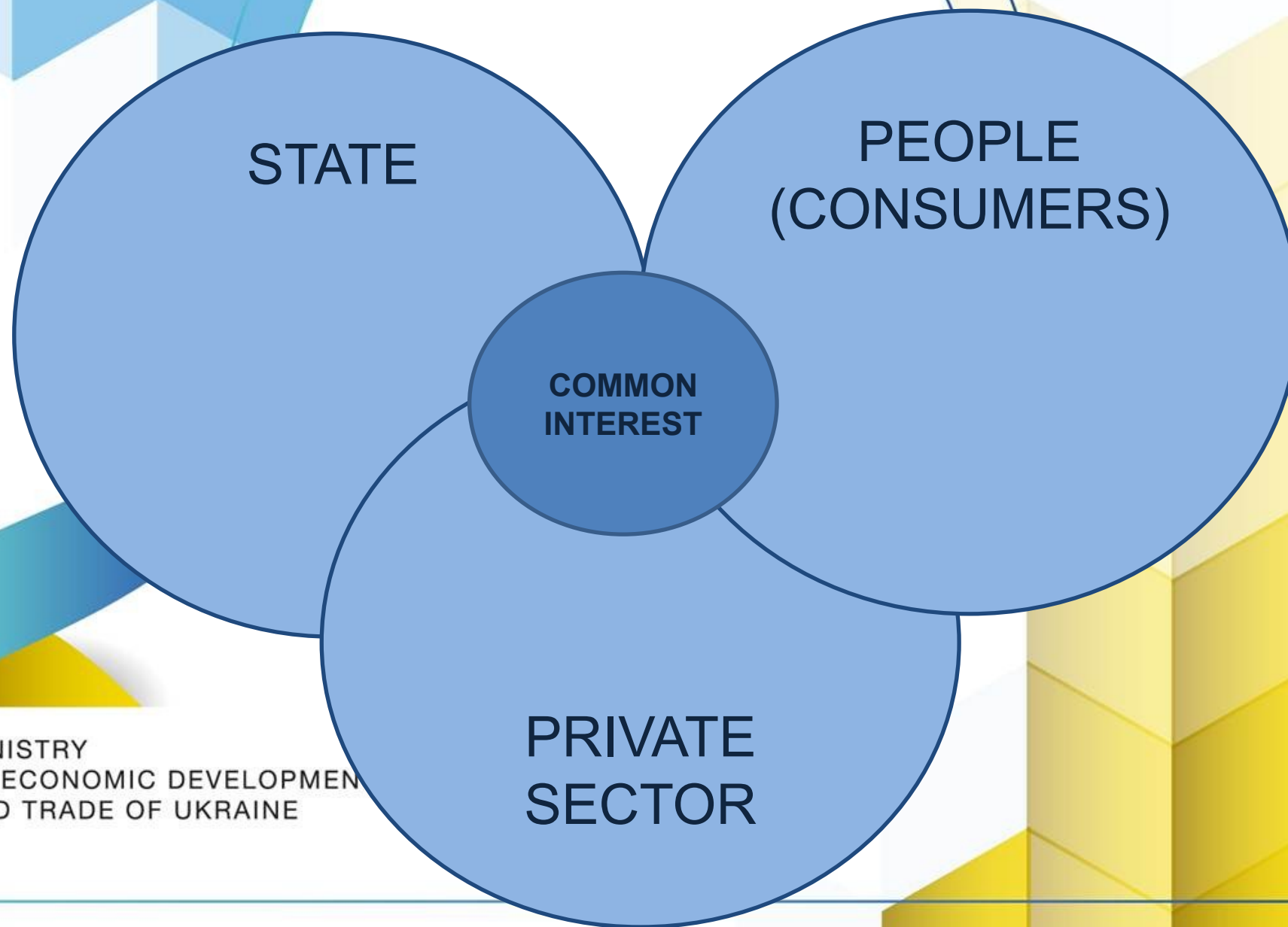

Meaning of Public Private Partnership (PPP)

- collaboration between public and private sector that is carried out on the basis of the agreement in an order;
- belongs to the signs of PPP

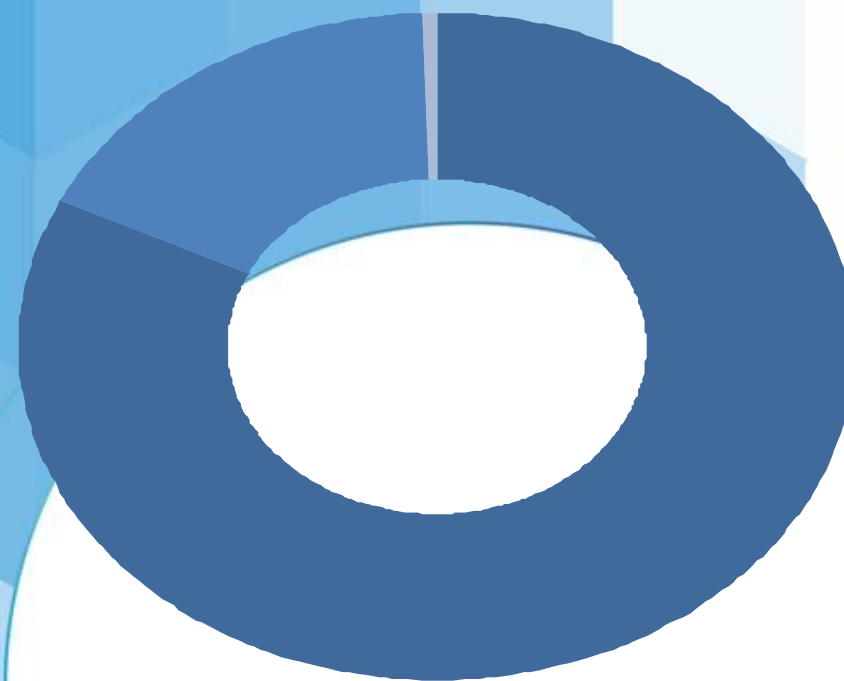

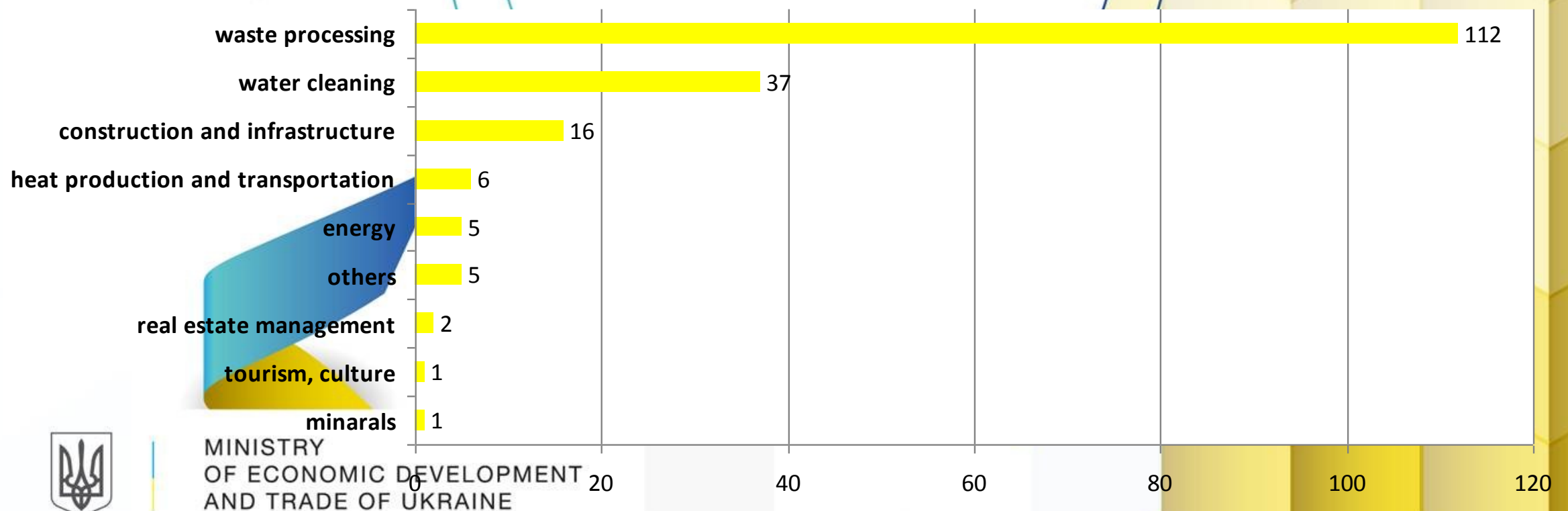

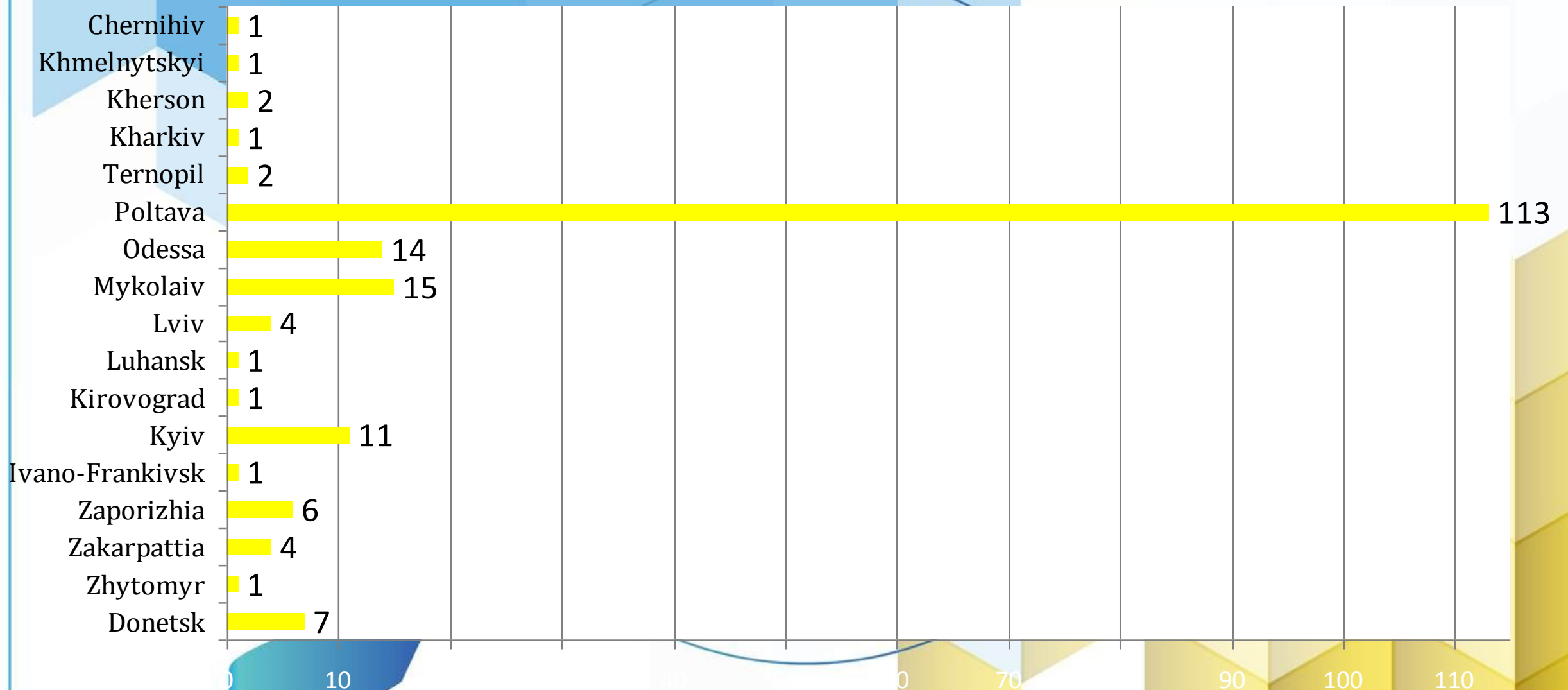

Development steps of the PPP legislation

Draft Law of Ukraine "On Amendments to the Budget Code of Ukraine to enable the capture of long-term obligations under the public private partnership" (reg. № 4565)

improved calculation of concession fees (Decree of Cabinet of Ministers of Ukraine from 04.02.2016? № 130 "On Amendments to the Decree of Cabinet of Ministers of Ukraine of 12 April 2000 № 639")

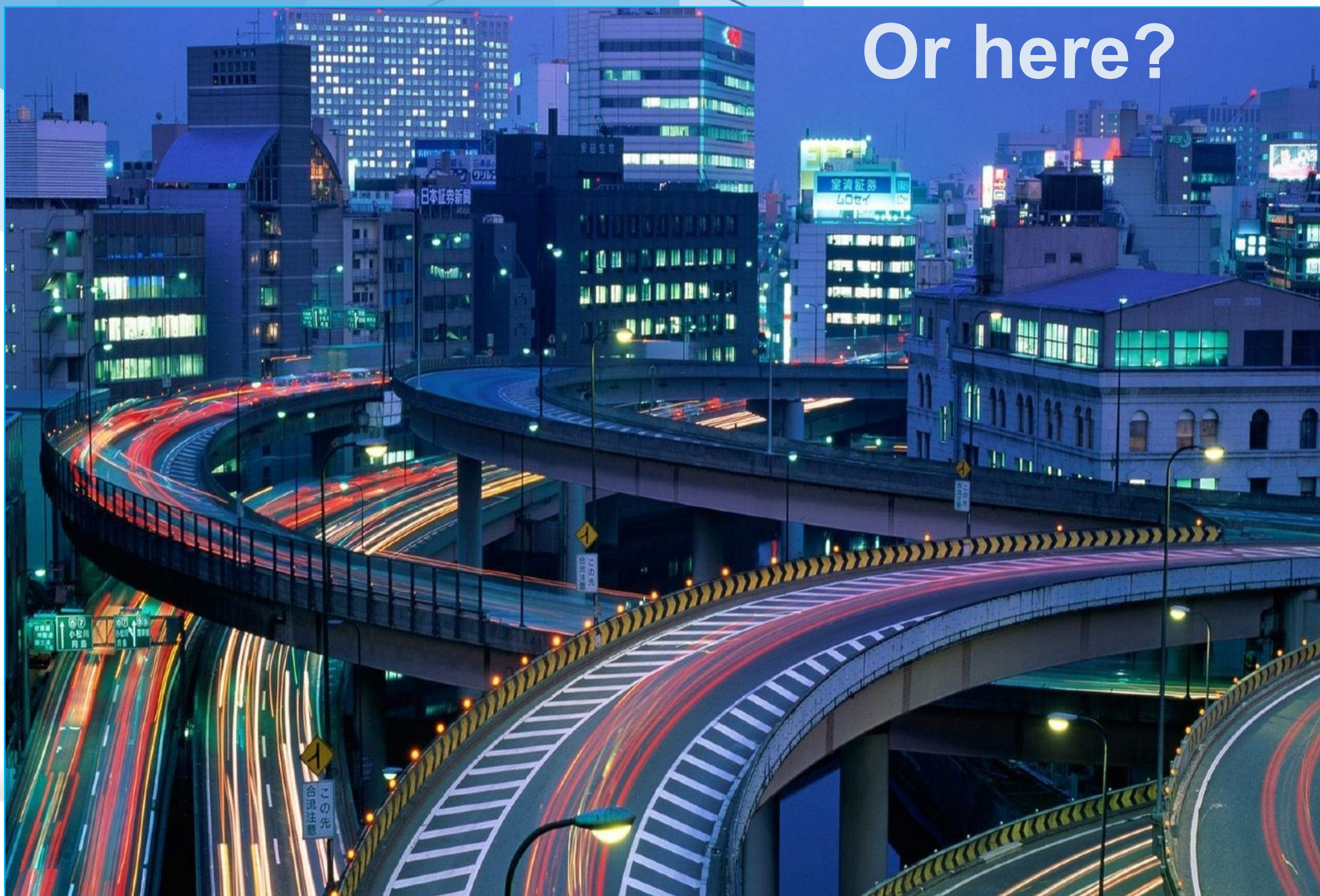
Decree of the Cabinet of Ministers of Ukraine from 16.11.2016 № 815 "On Amendments to orders approved by the Cabinet of Ministers of Ukraine from 11 April 2011 № 384", which improved order of competition to determine the private partner for the implementation of public private partnership of state, municipal property and facilities belonging to the Autonomous Republic of Crimea and introduced new approaches to analyze the efficiency of public private partnership

developed and submitted to the Government the draft decree of the Cabinet of Ministers of Ukraine "On Approval of Procedure for step-in-right for private partner under a contract concluded within public-private partnership"

Creation of the interdepartmental working group on concession legislation reform to develop new Law of Ukraine "On Concessions"
