Directions of R&D

- **developing of new technologies - 11%**
- **developing of new products - 12%**
- **"other" (draft legal analysis, forecast, technological documentation) - 58%.**

Directions of investment

- **in capital construction accounted - about 55% of the total investment**
- **in equipment and vehicles - about 35%**
- **in intangible assets - about 3%.**

Obstacles to innovation

- some unresolved issues in the legal field of activity;**
- underdeveloped innovation infrastructure;**
- lack of financial resources in the participants of science, technology and innovation activities;**
- lack of state support;**
- expensive financial resources.**

THE MAIN DIFFICULTIES OF PPP IN INNOVATION

Unaware of the crucial role of intellectual property in economic development by leaders of industrial enterprises;

Lack of innovation infrastructure capacity (financing, staff), that resolve some issues of commercialization of scientific results in various stages of completion;

Lack of effective mechanisms to attract scientific results into economic circulation.

- "On the development and support innovation“;
- "On Amendments to the Tax Code of Ukraine“;
- "On Amendments to the Budget Code of Ukraine (on stimulating innovation)“;
- "On Amendments to Certain Legislative acts of Ukraine concerning stimulation of innovation“.
- "On Amendments to the Law of Ukraine" On state regulation of activities in technology transfer " ,;

LEGISLATION IMPROVEMENT

Law of Ukraine “On supporting and development innovation” will provide:

- determining forms of public-private partnership in the field of innovation (clusters, technological platforms, startups);
- determining instruments of PPP in innovation;
- simplification of procedures for obtaining state support on innovation;
- creation of the Innovation Development Fund;
- formation mechanisms for attracting private domestic investments in innovation development by creating innovative venture capital funds.

SUBSIDIES ON CREATION OF INDUSTRIAL ENTERPRISES OF HIGH-LEVEL SECTORS

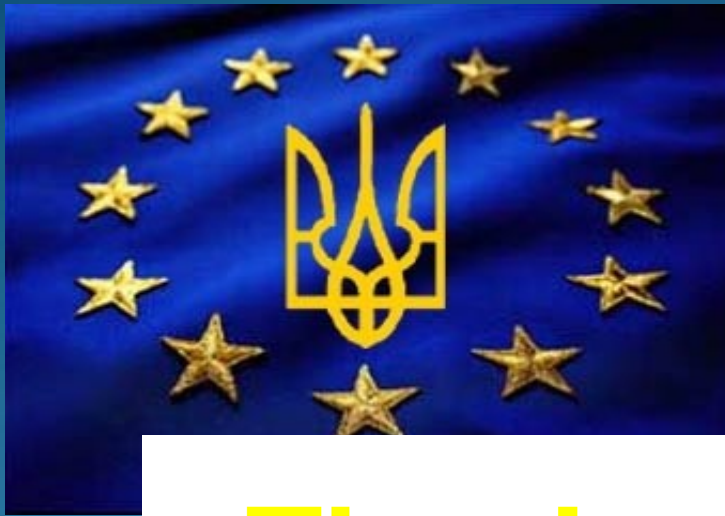
Members:

- scientific institution or university;
- industrial enterprise.

Creating a high-tech production should include:

- scientific research made by university for industrial enterprise (in the amount of subsidies);
- directing by industrial enterprise on creation of high-tech production its own funds in an amount not less than 100 per cent of the subsidies;
- additionally financed by industrial enterprise R&D in the amount not less than 20 per cent subsidy.

The result of the establishment of high-tech manufacturing is the production of industrial enterprise of products with high added value, developed under the project.
